



**Section V. - Discipline/Dismissal**

Corporal punishment (paddling) is one form of discipline that may be utilized by Central Academy. Please mark one of the following:

\*If corporal disciplinary action is deemed necessary and you have selected – **DO NOT PADDLE MY CHILD,** the student(s) will be suspended for 2 days. No makeup work will be granted and zeros will be recorded for class work.

It is agreed that Central Academy shall have the right to suspend or expel any student who violates the policies, rules or regulations of Central Academy whether now in existence or hereafter adopted. Central Academy reserves the right to terminate any education contract. Parents will be notified if a student is suspended or expelled. If disciplinary action results in the expulsion of a student, the remaining financial portion of the contract is due and payable. Until all financial obligations are met, grades, transcripts, or records will not be released by the school.

**Section VI. Concession and Work Requirements**

Parents are required to work one or more nights in the concession stand and other fundraising activities as scheduled. Failure to show up and work will result in a \$100.00 fine per incident.

**Section VII. Raffle**

Fall Raffle payment of \$400.00 for the first child and \$100.00 for each additional child is due on or before October 31, 2016. Spring Raffle payment of \$300 per family is due on or before March 15, 2017. All tickets must be sold or PAID IN FULL on or before the listed due date. Unsold tickets cannot be added to your tuition. If the tickets are not sold or bought by the patron, the patrons name will not go on the unpaid tickets or be put into the drawing. **PATRONS WILL HAVE THIRTY (30) DAYS TO PAY THE BALANCE DUE OF ANY UNSOLD TICKETS.** Patrons registering after the raffle drawing will have the amount added to their contract, this amount will be payable in three (3) monthly installments.

\_\_\_\_\_ **No Raffle Option** – A patron may elect not to participate in the raffle by adding the amount as listed above to their tuition. If this option is selected, you will not be given any tickets and not be entered into the raffle. Please initial above if you want to use the No raffle option

**Section VIII. School Fundraising Events**

Parents or guardians are required to participate in all required school sanctioned fundraising activities during the school year. **UNPAID** fundraising items will be added to your account and due at the end of the month the fundraiser was held.

**Section IX. – Medication**

**DO** or **DO NOT** provide my child with basic medication for head and body aches such as Ibuprofen or Acetaminophen

**Section X. – Mississippi Association of Independent Schools (MAIS)**

Central Academy is a member of the MAIS. Any person who causes problems at Central Academy or any Central Academy academic or athletic event that results in a fine(s) toward Central Academy from the MAIS will be required to pay the fines.

**Section XI. – Withdrawal**

I understand and agree I am financially responsible for tuition and fees for the entire school year, and that tuition and fees are due and payable as indicated on this contract. Should I remove my child(ren) from Central Academy, regardless of the reason, I am still obligated to pay the remaining balance of tuition and fees, plus any costs of arbitration and/or collection.

**Section XII. - Parental Permission to Publish Information**

I/We the undersigned am the person(s) with legal authority to give permission to the faculty, staff and employees of Central Academy to publish either in print media or on the school website information concerning said student. By initialing the following statements, I give the authority contained in said statement to the faculty, staff and employees at Central Academy:
